QUALIFICATIONS:

Intermediate **OR** 'A' Level (minimum 02 subjects) from a recognized Institution.

PROFESSIONAL QUALIFICATIONS:

- Valid Pakistani ATPL or CPL/IR or Certificate from the Director General Pakistan Civil Aviation Authority (PCAA) confirming that Pakistani CPL/IR is under issue.
- Minimum 2000 hours flying experience including 500 hours on Category 'B' aircraft (Multi Pilot Aircraft 5700 kg or more and less than 40,000 kg).

MAXIMUM AGE:

56 years as on 15th March 2010.

SELECTION PROCEDURE:

- ◆ Eligible candidates will undergo a written test. Results of written test will be declared only in terms of pass or fail, and marks will not be declared or demanded.
- ◆ Successful candidates in the written test will be called for interview.
- ◆ Candidates will undergo a Simulator Evaluation Check.
- ◆ The candidates who qualify the above steps will be called for Final Interview.
- ◆ Only successful candidates will be informed accordingly.

Ineligibility : Following will render an applicant ineligible:

- ◆ The candidates who don't possess any of the above mentioned specifications/qualifications.
- ◆ Failure to qualify steps of the Selection Procedure given above.
- ◆ Concealing / With-holding of information and making incorrect declaration.
- ◆ Using extraneous pressure, direct or indirect influence on the Selection Board or PIA Management.
